2007 Training Subsidies

The Promoting Excellence in ECI Project offers agencies funding to be used for two training programs in the first half of 2007:

1. **Strengths Based Training (2 days)** offered by Bernadette Glass (http://www.eciavic.org.au/professionals/Promoting_Excellence.html)
2. **Family Partnerships Training (5 days)** as developed by Professor Hilton Davis (<http://www.rch.org.au/emplibrary/ccch/FamPshipsTrain.pdf>)

If you are (i) an ECI practitioner wishing to do either of these programs or (ii) an ECI manager who wants to upskill staff in these areas, please note that subsidy is available to attend the regular public enrolment courses of each of the above programs.

Eligibility

- Staff must be currently employed by one of 13 Early Childhood agencies in the Northern metropolitan region and training must be booked before June 30th 2007. SCS staff are encouraged to apply for this training but will not be eligible for this subsidy. DHS will consider funding through their appropriate professional development budget.

Amount of funding

- Each agency, regardless of size, is eligible for two subsidised staff for each of the above programs.
- The subsidy cannot be applied to programs other than those above.

Application process

1. The manager of the agency should apply for the required number of places in a course with the course provider.
2. To claim a subsidy, the manager of the agency should email Andrew Hollo (ah@workwell.com.au) a copy of this form.
3. Applications close Feb 23rd 2007.
4. Applications will be assessed by the Excellence in ECI Steering Committee and their decision will be final.
5. Upon approval by the committee the agency manager will be responsible for invoicing Broad Insight Group in order to access the funds.
